PRICES & ADMISSION. MAXIMUM 1 PET PER APARTMENT

Cost: 10€ daily.

- **Deposit:** 100€ to be paid in cash on arrival and will be returned once the apartment has been checked for possible damages.
- Admission: Dogs up to 20 kg, not including dangerous breeds such as Bull Terrier, Rottweiller & Saint Bernard. This establishment is authorised to demand the presentation of the dog's sanitary documentation or passport.

Notes: Dogs are not allowed in this establishment's public areas. (Clubhouse, swimming pools, golf course and public gardens).

INTERNAL RULES

1) Dogs shall always be tied and wearing a muzzle. Under no circumstance shall they walk freely in the urbanization.

2) Pets shall not defecate in the gardens or other communal areas.

3) Owners shall avoid dog barking during rest hours, which are from midnight to 10:00 am.

4) Equally, from 15 :00h to 17 :00h, as these are considered resting hours by the urbanization's inhabitants.

5) It's forbidden to leave food at front doors, private areas and at communal areas for the pets.

6) Pets shall not roam freely disturbing the rest of the neighbourhood by entering areas that are not assigned to the guests.

Suggestions: Please ensure that you leave the accommodation in the same way that you would like to find it on arrival. Travelling with pets is a privilege, don't loose it.

RESERVATION PERIODS WITH DOGS

From 1st of January to 30th of June From 1st of September to 31st of December

Easter and High Season (July & August) Excluded.

PASSPORT AND SANITARY DOCUMENTATION

Pets must have their corresponding sanitary documentation when the authorities ask for them.

- Pets must have their vaccines against rabies and should be identified by a chip or tattoo. This should be complied with in accordance to the IDO 11784 law. There are many organizations where you can register the electronic number. This will make it easier to find your pet in case of loss.
- The new UE passport of 2 parts. One part has the general information of your pet, name, vaccines, medical treatments, if it has, and general medical information. The other part can be compiled by the editor.
- Pets under three months of age don't have to be vaccinated, but the owner, but the owner of the pet must prove that the little pet has lived in the same place since it was born and that it hasn't been in contact with other animals which could carry rabies. Your vet can inform you on how to get this document. The puppy can also cross the frontier if it is accompanied by its mother and if it is still dependant on her. Each member country has the right to deny the entry to a puppy, especially in countries such as England, Ireland and Sweden. It will probably be difficult or impossible for your puppy to enter.
